All signatures shall be in Black or dark ink only, and capable of legible reproduction.

The trustees/directors names are printed on the top set of lines to indicate who was present when setting the assessment amount. One trustee/director is required to sign the form in front of a Notary Public, to acknowledge the accuracy of the minutes. A Notary Public is available at this office between the hours 7:30 A.M. and 4:00 P.M., Monday through Friday. If you wish to use our service, please bring document to our office together with valid i.d. to sign form and notary journal.

At least 30 days must be given before the bills become due and delinquent.

We ask that you do not alter the forms. Do not write in margins – The County forbids it. Also, the enclosed personnel form must be completed per the instructions, and returned along with One (1) copy of the Minutes form, to update our records.
